

VA Granted 1 Millionth Benefit Claim for Veterans and their Survivors Under the PACT Act

The VA granted its 1 millionth PACT Act-related disability compensation claim to Veterans and survivors since President Biden signed the bill into law on August. 10, 2022. The grant rate for these claims is 75% – a sharp increase from pre-PACT levels – and VA has delivered more than \$5.7 billion in earned benefits to these Veterans and survivors. Through the PACT Act, VA has been able to help millions of Veterans get the health care and benefits they deserve.

VA Celebrates Five Years of Appeal Modernization

This year marks five years of the VA's implementation of the Veterans Appeal Improvement and Modernization Act (AMA). Signed into law on February 19, 2019, it was among the most significant statutory changes in decades to benefit Veterans because it restructured how VA processes appeals of disability compensation claims. The AMA allows Veterans three decision review options to dispute a benefit decision, delivering timely resolutions and a streamlined process regardless of the chosen route.

If you can't work due to a disability related to your military service, you may qualify for Individual Unemployability. This program allows VA to compensate certain Veterans at the 100% rate, even if VA has not rated their service-connected disabilities at that level.

When the GI Bill became law in 1944, it included a home loan program for Veterans. Despite several updates to the law to reflect current market conditions, support for Veterans dependent on wheelchairs still needed to be addressed. The answer was the Specially Adapted Housing (SAH) program, and one of the earliest homes built with the grant money was designed by acclaimed builder Frank Lloyd Wright. In the first nine years of the SAH program, around 6,500 World War II and Korean War Veterans used the grant for wheelchair-accessible homes. Kenneth Laurent, a paralyzed World War II Navy Veteran, uniquely benefited by contracting Wright to build a house for him and his wife in Rockford, Illinois.
