OC Veterans Service Office (VSO) Launches New Video on College Tuition Fee Waiver for Veteran Dependents



The College Tuition Fee Waiver for eligible Veteran Dependents waives mandatory system-wide tuition and fees at any State of California Community College, California State University, or University of California institution. To help with the application process, the VSO created a short video that guides applicants through the process in under five minutes. The video covers eligibility, the required documentation, and what to expect after submitting an application.

#### VSO Awarded Grant to Link Veterans to Mental Health Services

On June 25, 2024, the OC Board of Supervisors approved the VSO to receive a twoyear Mental Health Services Act (MHSA) grant from the California Department of Veterans Affairs (CalVet) to continue mental health outreach for California Veterans.

Through the MHSA grant,a Veterans Case Navigator (Navigator) will facilitate local coordination, provide case management, and establish connections to wraparound services, bridging gaps veterans may encounter when accessing mental health services. The Navigator will refer within the County's current mental health system of care and focus on building community partnerships to improve engagement outcomes for veterans, military members, and their families. Goals include enhancing access to care by linking veterans with existing mental health and case management services, while also fostering partnerships with service providers and higher education institutions.

# **DID YOU KNOW?**

If you're a disabled Veteran with a qualifying disability, you may be eligible for a Disabled Veteran (DV) License Plate. DV License Plates exempt Veterans from paying vehicle registration and license fees.

To qualify in California, Veterans need to meet CalVet's definition of a Disabled Veteran. This includes any person who, as a result of injury or disease suffered while on active service with the U.S. Armed Forces, experiences any of the following:

- 1. A disability rated at 100% by the U.S. Department of Veterans Affairs (or the military service from which the Veteran was discharged) due to a diagnosed disease or disorder that substantially impairs or interferes with mobility.
- 2. Severe disability requiring the use of an assistive device.
- 3. Loss, or loss of use, of one or more limbs.
- 4. Permanent blindness as defined in Section 19153 of the California Welfare and Institutions Code.
